

## WORKING SPACE at CERCCO 2019 / 20 – General conditions

### Introduction

CERCCO is the centre for experimentation and realization in contemporary ceramics of Geneva University of Art and Design (HEAD). It offers exceptional technological resources including ceramic, moulding and firing studios, as well as an access on the rapid prototyping workshop, equipped a CNC 5 axes, a 3D prototyping printer and a laser cut machine etc.

CERCCO is a competence centre that encourages its users to experiment with the artistic and technical possibilities of ceramics and polymers.

## 1 - Residency

CERCCO is inviting applications for two 3-month residencies in the form of a working space provided free of charge during the academic year 2019/20.

The 1st residency (Art oriented) is planned from September 23th until December 13th 2019
The 2nd residency (Design oriented) is planned from February 24th until May 15th 2020

This offer is open to designers, artists, architects and ceramists wishing to experiment and to carry out a specific project (producing works for an exhibition, development of a design project, experimentation with new ceramic materials, etc.)

# 2 - Admission criteria

- Open to designers, artists, architects or ceramists who have been professionally active for at least two years
- Project proposal consistent with the technical possibilities of the CERCCO studios (an experimental phase is to be incorporated for each project; the resident subsequently carries out his/her project in complete autonomy)

### 3 – Jury

The jury comprises:

- several members of the teaching staff of CERCCO or of HEAD Geneva
- one or more professionals designated by CERCCO from the fields of art, architecture or design

## 4 - Awarding of residencies

The Director of HEAD – Geneva will award the residencies on the basis of a proposal from the jury. The jury can, if necessary, refuse to allocate the residency. The deliberations of the jury are strictly confidential and there is no right of appeal on the part of the candidates.



## 5 - Deadlines and Application Documents

### 6 - Accommodation and expenses

A room, for which the rent of 500 Swiss francs/month can to be met by the resident. The resident can contact the Embassy of Foreign Artists – a place of residence and lodging for foreign artists in Geneva, Maison Baron, Rue Subilia 45, 1227 Carouge (www.eofa.ch)

All subsistence and travel expenses are to be covered by the resident.

### 7 – Participation in implementation costs

HEAD – Geneva will contribute 5000 Swiss francs maximum to assist with the resident's project implementation costs, corresponding to the provision of materials, raw materials and firing. All other implementation costs are to be met by the resident.

# 8 - Communication and compulsory reference

At the end of the residency, the resident will submit to HEAD – Geneva, free of charge and free of rights, professional quality photographic documentation, as well as an explanatory text on the project. (FR/EN)

The name of HEAD – Geneva must be systematically mentioned in any dissemination of the project carried out during the residency (exhibitions, publications etc.) according to terms to be agreed in particular cases or by the compulsory reference :

### 9 - Ownership of the works

The works remain the property of the resident.

HEAD – Geneva reserves the right to select – in agreement with the participant – one piece for its collection. This piece will be in the property of HEAD-Geneva

### 10 - Insurance and visas

The resident is responsible for covering the costs and following the necessary administrative procedures with the Swiss authorities to obtain the visas and/or residency permits required for the duration of the residency.

The resident must have individual health and accident insurance cover as well as personal liability insurance.
